Preamble

The GNU General Public License is a free, copyleft license for software and otherkinds ofworks.

The licenses for most software and other practical works are designed to take awayyourfreedom to share and change the works. By contrast, the GNU General Public License is intended toguarantee yourfreedom to share and change all versions of a program--to make sure it remains free softwarefor all its users. We, the Free Software Foundation, use the GNU General Public License for

most of oursoftware; it applies also to anyother work released this way by its authors. You can apply it to yourprograms, too.

When we speak of free software, we are referring to freedom, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software(and charge forthem if you wish), that you receive source code or can get it if you want it, that you canchange the software oruse pieces of it in new free programs, and that you know you can do these things.

TERMS AND CONDITIONS

0. Definitions.

"This License" refers to version 3 of the GNU General Public License.
